Jharkhand Combined Entrance Competitive Examination (J.C.E.C.E.) - 2020**

In continuation of Advt. No. J.C.E.C.E.B./06/20 - 38 dated 01.07.2020, it is informed that upper age limit for B.V.Sc. & A.H. Course will be 25 years on or before the 31st December of that year of his/her admission to the 1st year of Bachelor of Veterinary Science and Animal Husbandry course.
