Regarding Preparation of State Merit Rank on the basis of NEET(UG)-2018 Result

Online Applications Forms are invited for preparing the State Merit Rank & conducting the Counselling from candidates who have qualified in NEET (UG) – 2018 and fulfill the following eligibility criteria:-

- a) **Residential Criteria:** The Candidate must be a citizen of India and Local/Permanent resident of Jharkhand. The "Local Resident of Jharkhand" has been defined & identified in 7/Aa. Niti (Sarvdaliaye Baithak) 27/2002 (Khand)ka.-3198/, dated 18.04.2016 of Personnel, Administrative Reforms and Rajbhasa Department, Govt. of Jharkhand. The Notification copy is available under **Downloads** column on website.
A Candidate will have to submit/show Local Resident certificate in proper format in ORIGINAL at the time of Counselling, issued by competent authority [Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The Residential Certificate issued by any other authority will not be entertained and his/her claim will be rejected. The Local Resident certificate format is available under **Act & Circular** column on website.
- b) **Reservation on Caste Basis:** The current reservation policy of Govt. of Jharkhand will be followed for admission in all courses at Govt. and Non-Govt. Institutes. Candidates claiming reservation will have to submit/show Caste certificate in proper format in ORIGINAL at the time of Counselling, issued by competent authority [Sub Divisional Officer – (Civil) or Dy. Commissioner of Jharkhand State]. The caste certificate issued by any other authority will not be entertained for claiming reservation and his/her claim for reservation will be rejected and the candidate will be deemed to belong to General category [Ref. Letter No.- 7/Aa.Ni. – 018-10/2003 ka- 7072 dated 30-12-2003 of "Personnel, Administrative Reforms and Rajbhasa Department," Govt. of Jharkhand]. As per Memo no. 10007 dated 29.08.2012 of Deptt. Of Administrative, Personnel Reforms and Rajbhasa, Govt. of Jharkhand, Candidates belonging to BC – I & BC – II, have to submit/show the Caste certificate which includes Creamy Layer factor at the time of counselling. Caste certificate produced by BC – I & BC – II Candidates will be valid only if he/she does not belong to creamy layer & it should be mentioned in caste certificate. The caste certificate format is available under **Act & Circular** column on website.
- c) **Reservation for Person with Disabilities:** As per Memorandum (Letter No. 2249 dated 03.04.2018) of Personnel, Administrative Reforms and Rajbhasa Department, Ranchi. The concerned Memorandum is uploaded on the Board's official Website.
- d) Interested eligible candidates are requested to fill the **Application Form Online** from 23.06.2018 to 29.06.2018 on official website <http://jceceb.jharkhand.gov.in> by Clicking on "Click here for All Online Application Submission – JCECEB 2018" tab and following the given guidelines.

Following the preparation of the state merit rank as per above guidelines, Detailed information about counselling scheduled will be freshly advertised very soon.
